### 4 RULES AND DRAW

The following rules apply:

- JJIF competition rules (in their latest versions) and the Organization and Sporting code of JJIF Version (SC).<sup>1</sup>
- We appeal to all participants to respect the fair-play and JJIF book of ethics

#### 4.1 Draw

- No seeding will be applied. Draw will be made by the JJIF software, Sportdata

#### 4.2 Appeal and Challenge

Will be applied as defined in JJIF SC 3.0 Challenge and Appeal.

### 5 RIGHT TO PARTICIPATE AND CATEGORIES

Based on the JJIF SC 3.0 Entries of Competitors:

Each JJNO/CLUB/Member in JJIF may as much as he wanted add contestants in each category for this Open Championship

The age following age categories will be allowed to participate in this event

Name	Description
Adults (+18)	Older than 18 years
U21 (+18-21)	18/19/20 years old
U18 (+16-18)	16/17 years old
U16 (+14-16)	14/15 years old
U14 (+12-14)***	12/13 years old

Be aware: The Organisation and sporting Code of JJIF **A competitor can participate in only one age category in the same tournament.** Even if the categories are on different days, but within the same event, the same athlete cannot compete in both age categories.

## 6 REGISTRATION AND PARTICIPATION FEE

### 6.1 Registration:

### 6.2 Participation Fee

**35 € per individual athlete of Adult category**

**30 € for the age categories U21 and U18.**

**25 € for the age categories U16 and U14**

*Late entry and late payment fees will be applied.*

- Change of the category of an athlete: 10€
- Late entry: 10€
- Additional entering of a competitor on site: 75€

## 7 COMPETITION DRESSING AND PERSONAL REQUIREMENTS & ADVERTISING FOR GI AND NOGI

The national federations/Clubs/Athletes must manage that each athlete have their personal RASHGUARD with the next specifications:

- 1 rash guard with at least 80% the colour RED
- 1 rash guard with at least 80% the colour BLUE
- The JJNOs are then responsible for giving the back numbers to the athletes so that they can apply them to their Gi prior to the competition. The national federations must pay the back numbers for their athletes by themselves. Participating without an official back number is not allowed.
- Please observe the regulations of the JJIF as far as advertising on the Gi is concerned.
- It's not allowed to make video's or pictures from out of the coachboxes.

### 7.1 Referees

All clubs and or National Federations are asked to bring for each 10 athletes a referee, with the minimum license of National Referee. Please subscribe the referee also in the Sportdata event. The organizer can offer for the referees the hotel rooms.

### 7.2 Coaches

All official coaches should receive their accreditation cards during accreditation. Teams without an official coach will participate without coaching (no athlete or other officials will be allowed to enter the field of play unless they register as coaches).

### 7.3 Medical personal

JJNO's may have its medical personnel. To receive an accreditation card as medical personnel the attendance at the medical meeting is mandatory.

### 7.4 Dress code

Coaches and medical personnel coming on the FOP must wear official team dresses<sup>2</sup>, shorts, flip-flops, hats are not allowed. According to GAISF guidelines, every competitor who has won a medal has to attend the ceremony to receive their trophy in person.

### 7.5 Flags and Anthems

The head of each delegation, or designated responsible of each national federation, must check the flag and the national anthem during the accreditation process.

### 7.6 Financial conditions

The organisation of the travel to Turkish and Travel expenses are the responsibility of the participating countries.

Each federation must pay the cost of the accommodation (if they book the proposed opportunities by the Turkish federation) and the participation to local the organiser.

Payment must be done by bank transfer until **November 28<sup>th</sup> 2024** or take pre-approval that you will pay cash at the official registration and accreditation.

No registration refund for participants not attending the Championship will be made.
